Representative: Carla Coolman

Corporation for National and Community Service

Council on Environmental Quality

Representative: Miguel Ayala



Miguel A. Ayala is the Deputy Director of Communications at the White House Council on Environmental Quality. In his role, he handles communications and media for the Council, and its Chair, Nancy Sutley, who serves as the principal environmental policy adviser to the President. The Council on Environmental Quality coordinates Federal environmental efforts and works closely with agencies and other White House offices in the development of environmental policies and initiatives. In addition, CEQ oversees Federal agency implementation of the environmental impact assessment process and oversees the Office of the Federal Environmental Executive, which works to promote sustainable environmental stewardship throughout the Federal Government.

Prior to joining CEQ, Ayala was the Deputy Press Secretary for U.S. Senator Debbie Stabenow (MI). There he coordinated radio and social media for the Senator, and booked national television interviews, as well as prepared talking points and statements on various issues. Before that, he was the Communications Director for the Congressional Hispanic Caucus (CHC), under the Chairmanships of Congressman Joe Baca (CA) and then Congresswoman Nydia Velazquez (NY). While at CHC, he was the lead staffer for several CHC Task Forces, including Education, Agriculture, Veterans, and Green Economy and Renewable Energy. He began his government career in the office of Congresswoman Barbara Lee, where he last served as a Legislative Assistant, dealing with Western Hemisphere foreign relations, LGBT policy, and immigration issues. In his spare time, Ayala has remained involved with various organizations. He served as Co-Chair of the Gay, Lesbian and Allies Senate Staff (GLASS) Caucus. He served on the national board of Sigma Lambda Beta International Fraternity for four years, and has remained active with the DC-based Mid-Atlantic Alumni Association of the organization. He was inducted into the Chicago Gay and Lesbian Hall of Fame, and recognized by Out Magazine, Advocate Magazine, the Human Rights Campaign, the Gay, Lesbian and Straight Education Network, and several other publications and organizations for being an out student Board Member of the Chicago School Board of Trustees and starting a national network for high school gay-straight alliances. Most recently, he was recognized by the Latino LGBT History Project for his work in public policy and his continued commitment to LGBT and Latino issues. Ayala is a graduate of Whitney M. Young High School in Chicago, and received a Bachelors degree from DePaul University.

Angela Mariana Freyre is the 20th General Counsel and Senior Vice President of the Export-Import Bank of the United States. In this capacity, she is the Bank's chief legal officer, managing its attorneys and overseeing diverse transactions and litigation portfolios, and a member of the Bank's senior management team.

Prior to joining the Obama Administration, Ms. Freyre served as Senior Vice President and Deputy General Counsel for Legal and Strategic Affairs at the Nielsen Company, a global leader in the media and marketing information business whose clients include the leading US media companies. She managed and expanded strategic relationships with Nielsen's most important media clients, led teams in the negotiation of Nielsen's most important revenue and strategic contracts, and supported Nielsen's government affairs team.

Previously to Nielsen, Ms. Freyre practiced law in New York and Paris, developing an international corporate practice, including joint ventures, mergers and acquisitions and complex financial transactions, with major US and foreign clients for ten years each at Coudert Brothers, LLP, where she was a partner, and Mudge Rose Guthrie Alexander & Ferdon, LLP.

NASA

Representative: Joeletta Patrick



Joeletta Patrick is a native of Greensboro, N.C., where she attended North Carolina A&T State University and received a B.S. in electrical engineering. Upon graduation, she moved to Houston, Texas, and began her career in the NASA family at Johnson Space Center. She worked as a flight controller for the International Space Station as the lead inventory stowage officer for ISS mission 2A.1/STS-96. She transitioned from the Mission Operations Directorate to Engineering to work as a time-phased power analyst. Patrick returned to the Mission Operations Directorate and became a civil servant in August 2004 working in the space station program in the Electrical Power System group.

Patrick's career has been marked by positions of steadily increasing responsibility, leadership and assumption of new challenges. In 2009, after working as a certified flight controller, she served as the acting program manager of Johnson Space Center's Minority University Research and Education Program, or MUREP. To increase the diversity of her career, she moved into an acting position in the newly developed Johnson Space Center Integrated Project Office housed in the Public Affairs Office. In 2010, Patrick was selected to serve permanently as the program manager of Johnson's MUREP program. During the course of her career in this position, she has served as the agency liaison for the Hispanic Engineering, Science and Technology week. Her leadership resulted in a JSC Group Achievement Award for outstanding achievement in aligning Johnson with NASA's goal to inspire, engage and educate and the JSC Superior Achievement Award for her outstanding leadership, development and integration.

Patrick has worked with internal and external organizations, institutions, federal agencies, and the community through various Office of Education assignments. Her work has reflected her commitment to leveraging university relationships and investments, growing the number of diverse students prepared to work in STEM-based fields, supporting STEM initiatives, and serving as a spokesperson for NASA's commitment to STEM.

In September 2013, Patrick was selected as the agency's program manager for MUREP at NASA Headquarters in the Office of Education. She enjoys volunteering in the community and serving in social and professional organizations. She is a member of the National Society of Black Engineers, the Society of Women Engineers, and Delta Sigma Theta Sorority Inc.

National Endowment for the Arts

Representative: Anthony J. Tighe



Anthony J. Tighe is the Coordinator of Federal Partnerships in the Office of the Chief of Staff at the National Endowment for the Arts (NEA), the federal agency that supports nonprofit arts throughout the United States. Tony assists the NEA in developing public sector partnerships. He also serves as the NEA's representative to the several White House Initiatives. The NEA was the first federal funder for 105 Voices of History, an honors choir of students from HBCUs that performs each year at the Kennedy Center. Tony has established partnerships with many federal agencies, including the Forest Service; the Appalachian Regional Commission; the National Park Service's Rivers, Trails and Conservation Assistance program; and DOJ's Office of Juvenile Justice and Delinquency Prevention. Much of his work has centered around cultural heritage tourism development, particularly in rural areas. National Science Foundation

Representative: Sylvia James



Dr. Sylvia M. James is the Director of the Division of Human Resource Development (HRD) in the National Science Foundation's (NSF) Directorate for Education and Human Resources (EHR). As Division Director, she oversees a \$129 million budget and a talented team of 25 scientific and administrative staff. The mission of HRD, as exemplified by its seven longstanding programs, is to contribute to the creation of "...a well-prepared and competitive workforce of scientists, technicians, engineers, mathematicians, and educators that reflects the diversity of the U.S. population."

During her 13 year tenure at NSF, she served as the Acting Division Director of the Division of Human Resource Development, Acting Deputy Division Director of the Division of Research on Learning in Formal and Informal Settings (DRL), and the Lifelong Learning Cluster Coordinator. As Cluster Coordinator, she managed the Informal Science Education Program (ISE) which had a budget of \$64 million dollars, while also providing direction for the Innovative Technology Experiences for Students and Teachers (ITEST) program. She has served as a program officer for the ISE, ITEST, Faculty Early Career (CAREER), and the Advanced Technological Education (ATE) programs. She has also worked with the Innovation through Institutional Integration (I³) and Academies for Young Scientists (AYS) programs. Dr. James previously served as the Lead Program Officer for ITEST, and its predecessor, the After School Centers for Exploration and New Discovery (ASCEND).

Prior to coming to NSF, she was the Director of Education at the National Aquarium in Baltimore where she was employed for 14 years. While at the National Aquarium, she directed teacher training and youth enrichment projects supported by national funders such as the Howard Hughes Medical Institute, DeWitt Wallace Readers Digest Fund, and the National Science Foundation, as well as an assortment of local foundations. She has served as an education consultant for science education radio, youth publications, and museums. Dr. James is the author of seven children's books on marine animals, in addition to science education publications and reports. She is an adjunct science faculty member at Sojourner-Douglass College in Baltimore. She holds a Bachelor of Science degree in Biology from Loyola

University, a Master of Science degree from the Johns Hopkins University, and a Doctorate in Science Education from Morgan State University, all located in Baltimore, Maryland.

Office of National Drug Control Policy

Representative: David Mineta



David K. Mineta was confirmed unanimously by the United States Senate on June 22, 2010 to be the Deputy Director of Demand Reduction for the Office of National Drug Control Policy. In this position, Mr. Mineta oversees ONDCP Office of Demand Reduction which focuses on promoting drug prevention and drug treatment programs, as well as the agency's newly created focus on programs for individuals in recovery from addiction. Mr. Mineta's focus of drug prevention and treatment services has been longstanding. Since 1996, Mr. Mineta has worked with Asian American Recovery Services (AARS) throughout the San Francisco Bay Area. He started as a manager of a youth prevention program, but rose quickly to associate director and, since 2007, deputy director. As deputy director, he oversaw all agency grant writing and institutional technology departments, and assisted in strategic planning, community consortiums, and other necessary functions. Before joining AARS, Mr. Mineta was a counselor in the San Jose Unified School District and later in Santa Clara's Alcohol and Drug Department.

Office of Personal Management

Representative: Mauro Morales



Mauro Morales was appointed by President Barack Obama on November 2, 2009 to serve as Policy Counsel in the Office of General Counsel (OGC) at the Office of Personnel Management (OPM).

As policy counsel in the OGC, Morales works to ensure that OPM's missions are accomplished within the letter and spirit of all Federal statutes, regulations, and Executive Orders. OGC has two core goals. First, OGC strives to provide timely and accurate legal advice to the Director, Deputy Director, and program offices. Second, OGC strives to provide timely and effective litigation services to the Director by representing the agency in administrative tribunals and assisting the Department of Justice in defending OPM concerning human resource litigation issues.

Morales is currently on detail from OGC to the OPM Director of Diversity and Inclusion as a policy advisor for implementation of the Presidential Executive Order promoting diversity and inclusion in the Federal workplace.

Prior to accepting the OPM appointment, Morales was in private practice serving as managing partner in the Morales Law Group in Southern California. There he specialized in employment labor law and civil litigation. Morales has been a senior associate at McGuiness and Williams law firm in Washington, D.C., a general counsel to Lambco Engineering, Inc., and has served as a legislative director and chief of staff to both Representative Esteban Torres and Representative Loretta Sanchez.

Morales currently resides in Washington, D.C. He received his undergraduate degree from Georgetown University, and earned his law degree from the University of Southern California. Morales is licensed to practice law in the State of California and Washington, D.C.

Representative: Sean Jones



Dr. Sean L. Jones is a Senior Policy Analyst with the White House Office of Science and Technology Policy (OSTP) on detail from the National Science Foundation (NSF). His OSTP portfolio includes graduate education, grant reform, and workforce development, and enhanced inclusion of underrepresented groups in technology classes and professions. At NSF, Dr. Jones serves as a Program Director in the Division of Materials Research, where he co-manages the Materials Research Science and Engineering Centers and the Partnership for Research and Education in Materials program, which is a funding opportunity focused on increasing the number of underrepresented minorities engaged in materials research. He has also managed the Instrumentation for Materials Research Programs. Prior to joining NSF, Dr.

Jones was a research faculty member in the Department of Materials Science and Engineering at the University of Florida. He has also served as the Director of Engineering for Applied Plasmonics, Chair and Professor at Norfolk State University for both the optical and electronic engineering departments, and as a Technical Manager and Distinguished Member of Technical Staff at Bell Laboratories of Lucent Technologies. Dr. Jones received his B.S. in Ceramic Engineering from Clemson University and his Ph.D. in Materials Science and Engineering from the University of Florida. He has authored more than 30 peer-reviewed publications and has been awarded 9 U.S. patents with several others pending.

Office of Science and Technology Policy, Executive Office of the President

Representative: Vivian Graubard



Vivian Graubard serves as an Advisor to the United States Chief Technology Officer, Todd Park, within the White House Office of Science and Technology Policy (OSTP). She leads OSTP’s Tech Initiative to Fight Trafficking, which focuses on leveraging technological innovation to help combat human trafficking and enable victims to connect to help and support. She is also a leader within OSTP on initiatives to increase diversity within the tech community and to support greater education inclusion of girls and women in science, technology, engineering, and mathematics classes and careers. Vivian works closely with CTO Park on

the Presidential Innovation Fellows program—a new initiative that brings leading tech innovators into government for focused “tours of duty” to work on game-changing projects that help make government smarter, more effective, and more efficient. Before joining the Office of Science and Technology Policy, Vivian served as the Technology Coordinator for the White House Office of Presidential Correspondence, where she developed and wrote the first automated system for reading, coding, and responding to foreign language correspondence, an effort that led to the first-ever response to correspondence in Spanish by a President. She also serves as the Council Designee for Technology to the Council on Women and Girls. Prior to joining the White House, Vivian was a fellow at Polaris Project, a leading organization in the global fight against human trafficking. She also worked with The Emancipation Network in Kolkata, India, helping young girls who had been placed in orphanages after being rescued from sex trafficking enterprises. Vivian holds a Bachelor’s degree in Business Administration from American University, where she pursued a dual concentration in Information Systems and Technology and International Business.

Peace Corps

Jennifer Chavez Rubio is the Director of Gifts and Grants Management in the Office of Strategic Partnerships at the Peace Corps. She directs strategic partnership development and fundraising activities on behalf of the agency and oversees the Peace Corps Partnership Program, a small grants program that supports grassroots development projects in the 65 countries where Peace Corps Volunteers serve. Prior to the Peace Corps, Jennifer worked in the field of philanthropy at Silicon Valley Community Foundation developing cross-sector partnerships and managing corporate social responsibility programs on behalf of top corporations. She has also served as a Senior Program Officer at Genentech, Inc., a top biotechnology company, conducting the company's grant making and managing an employee volunteer program for more than 10,000 employees. Alicia Barrera, originally from Tampa, Florida, is a Program Specialist for the Peace Corps' Office of University and Domestic Partnerships where she manages a portfolio of partnerships with over 34 universities in the Northeastern region of the U.S. In addition to her work with university partnerships, Alicia leads a group of Latino employees at the agency, the Hispanic Association for Leadership and Opportunity (HALO). Prior to working for the Peace Corps, Alicia was a Peace Corps Volunteer in Sarapiquí, Costa Rica from 2008-2010. Her role in the community focused on prevention activities, youth empowerment programs, and parenting skills workshops in a rural community setting. Her passion for working with youth started long before her days in the Peace Corps. While in college at the University of South Florida, Alicia dedicated most of her time outside of her studies to working with inner-city youth as a tutor for the GEAR-UP program. Stacy L. Rodgers has a broad range of management experience in both the private and public sectors. Stacy brings more than 25 years of experience in working with Federal, state and local government agencies and non-profit organizations. She has successfully designed and implemented human service policies, programs and initiatives for municipal and state agencies. In February 2011 Stacy was appointed by the Obama Administration and serves as the Senior Advisor to the Acting Commissioner of the Social Security Administration (SSA). In this capacity, she serves as a member of SSA's senior management team and Liaison to the White House. Among her various duties Stacy oversees the agency's implementation of a wide range of Presidential

Executive Orders. Representative: Eric Waldo



Eric Waldo was appointed in November 2010 as deputy chief of staff for policy and programs in the Office of the Secretary. In this capacity, Waldo serves as a senior advisor on a wide array of policy, communications, and strategy issues. He serves as co-chair of the Advisory Council on Dependents Education, providing programmatic recommendations and counsel regarding Department of Defense Education Activity schools. Waldo also serves as the Department of Education's representative to the President's Task Force on Puerto Rico's Status and as the principal legal advisor to the secretary on legal appeals from the Office of Hearings and Appeals. Along with the deputy secretary of education, the secretary's chief of staff and the Department's human capital team, he will help lead the secretary's efforts to meaningfully communicate with and engage

Representative: Tara Trujillo


U.S. General Services Administration
