Executive Summary

- In FY 2009, the nation's 105 Historically Black Colleges and Universities (HBCUs) received \$4,780,696,771 in grants, student loans, and other allocations from 31 participating federal departments and agencies, mostly across six major funding categories (see tables 1 and2)
- Scholarship and tuition assistance for students accounted for the largest portion of this support at \$3,290,961,535.
- HBCUs received substantial support, roughly \$800 million, from federal efforts to stimulate the economy during FY 2009.

Introduction

As per Executive Order 13256, signed on Feb. 12, 2002 (see Appendix A), the President's Board of Advisors on Historically Black Colleges and Universities "shall prepare and issue an annual report to the President on the results of the participation of historically black colleges and universities in Federal programs."

The following report describes the support that the nation's 105 HBCUs received from the 31 participating federal departments and agencies during FY 2009.

During FY 2009, approximately 12 percent of all African American college students were enrolled in HBCUs.

Methodology

As per Section 6 of Executive Order 13256, the 31 participating departments and agencies are required on an annual basis to provide the White House Initiative on HBCUs (WHI-HBCU) with data that identifies the funds they provided to HBCUs during the previous fiscal year.

Most of the tables in this report contain three kinds of data: 1) funds provided to all Institutions of Higher Education (IHEs); 2) funds provided to HBCUs; and 3) the percentage of IHE funds awarded to HBCUs.

Although the WHI-HBCU received most of the requested funding data that is necessary to compile this report, data from some of the participating agencies and departments is not included in it. This is due to an agency either failing to submit its report altogether or not specifically disclosing its awards in accordance with the established funding categories. As a result, missing entries in the tables are designated as "n/a" meaning "not available."

The missing data elements did not significantly impact this report for two reasons: 1) most of the support across the major funding categories was provided by only a few departments and agencies; and 2) the major funders provided the requested data elements.

Where the first row in a table represents the sum of all of the data in the respective columns, missing data

generated an estimated sum that is lower than the real sum would have been had the data been provided. However, given the predominant support from the major funding agencies and departments, the missing data from those contributing smaller amounts generated errors in the total HBCU support as a percentage of the total IHE support that is usually less than 1 percent.

Regarding the data presented, the following should be noted:

- All of the tables within the body of this report are ordered by the amount of the funds provided to HBCUs. For further reference, the tables in Appendix E provide the same data but are ordered alphabetically by the names of the participating departments or agencies.
- The data for the previous year's (FY 2008) report was collected by the previous administration. Efforts by the Obama administration to improve the methodology employed in the classification and analysis of the data contributed to delays in the production of that report. Additional efforts to further improve these methods also delayed this FY 2009 report. As a result, the data tabulated in this report is not directly comparable with the data as it was classified for FY 2008 or in earlier years. Accordingly, this report will not present changes in funding levels that occurred from year to year.

The forthcoming FY 2010 report will, however, apply the final classification schema to the FY 2007, 2008, 2009, and 2010 data and will, therefore, include valid discussions of changes and trends in year- to-year funding levels

Part I. Overview of HBCU Funding in Fiscal Year 2009

Table 1 identifies the funds awarded by each of the participating federal agencies and departments to HBCUs and to all IHEs. As shown in the table, the 31 participating federal agencies and departments provided HBCUs with \$4,780,696,771 in FY 2009, representing 2.7 percent of the total \$174,472,080,687 that these departments and agencies awarded to all IHEs.

Of the 31 funding agencies and departments, four contributed more than \$50 million to HBCUs: Education, Health and Human Services, Agriculture, and National Science Foundation.

Table 2 displays the allocation of federal support for HBCUs across six major funding categories that, collectively, accounted for 84.2 percent of the total federal support for HBCUs in FY 2009.

Funding for scholarships and tuition assistance accounted for \$3,388,024,318, representing 70.9 percent of all federal support for HBCUs in FY 2009.



*The funds included within the line item for *Other Categories* accounts for the following: 1) ED allocations for items other than Federal Student Financial Assistance; 2) awards that were not categorized by the reporting agencies when submitted to the WHI-HBCU; and 3) additional funding categories reported by participating agencies (e.g., Program Evaluation, Fellowships/Internships, Third-Party Awards, Private-Sector Involvement, and Administrative Infrastructure).

As displayed in Figure 1, R&D was the second largest funding category at \$356,382,387, representing 48.2 percent of the remaining \$739,426,280 in funding *not* provided by the Department of Education (ED).

Table 3 provides information about the Department of Education's (ED) funding to IHEs and HBCUs in FY 2009. The data included in the table reflects funding that is unique to ED and is therefore not included in subsequent tables showing funding in other categories.

- ED provided \$3,329,362,906 in federal student financial assistance to HBCUs in FY 2009, which accounted for 82.3 percent of the total \$4,041,270,491 the Department awarded to HBCUs.
- ED also awarded HBCUs \$711,907,585 for activities other than student financial assistance, which represents 21.3 percent of the funds the Department provided to all IHEs for such activities.

Although ED provides the largest dollar support to HBCUs, its contributions do not directly correlate with the six major funding categories identified in Table 2 except for Scholarships and Tuition. Many of the Department's programs contribute to more than one of the other five categories in ways that are difficult to disaggregate. Accordingly, ED's contributions will not appear in subsequent tables showing categories of funding, except for Table 4, which displays the data for student aid.

Table 3 offers a general breakdown of ED's support to IHEs and HBCUs by disaggregating funds awarded in FY 2009 in accordance with the Department's two most basic funding categories: Federal Student Financial Assistance and Other Financial Assistance.

Part II. Allocations of Federal Support to All IHEs and to HBCUs, by Major **Funding Categories**

The tables in this section of the report detail the contributions of each participating federal department and agency in accordance with the six major categories identified in Table 2.

As shown in Table 2, funding for scholarships and tuition assistance was the largest source of federal funds for HBCUs, representing 70.9 percent of the total funds provided to HBCUs in FY 2009.

As shown in Table 4, the Department of Education administered the predominate amount of financial aid to HBCU students in FY 2009, accounting for 98 percent of their total funding.

As noted in Part I, R&D funding was the second largest category of federal support for HBCUs in FY 2009, representing 48.2 percent of the support outside of the funds provided by ED.

- Table 5 shows the departments and agencies that provided R&D awards to HBCUs in FY 2009. Of these contributors, four accounted for over 80 percent of these awards: **Health and Human** Services, Agriculture, National Science Foundation, and Defense.
- The HBCUs' R&D activities contribute to increasing the nation's progress in the fields of education, science, technology, engineering and mathematics (STEM), thereby helping to ensure the nation's ability to remain globally competitive, prosperous, and secure. These R&D activities also benefit new and existing health and safety initiatives aimed at enhancing the lives of the American people.

As depicted in Figure 1, **training** accounted for 15.7 percent of the federal support grants outside of the funds provided by ED in FY 2009.

As shown in Table 6, three agencies provided over 85 percent of the funds awarded to HBCUs in this category: **NSF**, **HHS**, and **Veterans Affairs**.

The **facilities and equipment (F&E)** category includes funds for construction projects, major repairs, equipment maintenance, and land use.

As shown in Table 7, three departments accounted for over 90 percent of the total F&E funds awarded to HBCUs in FY 2009: **Homeland Security, Agriculture, and Interior**.

Note: HBCUs received \$61,000,000 in *loans* from ED in FY 2009 as part of the Department's HBCU Capital Financing Program. The program provides HBCUs with access to capital financing or refinancing for the repair, renovation, and construction of classrooms, libraries, laboratories, dormitories, instructional equipment, and research instrumentation.

Funds allocated as **direct institutional subsidies (DIS)** can be used for education and general expenses. The federal government either places no restrictions on the use of these funds or permits their use across a broad range of funding areas.

As evidenced in Table 8, Agriculture provided over 90 percent of this support for HBCUs in FY 2009.

APPENDIX A -- Executive Order 13256

Executive Order—White House Initiative on Historically Black Colleges and Universities

By the authority vested in me as President by the Constitution and the laws of the United States of America, in order to advance the development of the Nation's full human potential and to advance equal opportunity in higher education, to strengthen the capacity of historically black colleges and universities to provide the highest quality education, and to increase opportunities for these institutions to participate in and benefit from Federal programs, as do other colleges and universities, it is hereby ordered as follows:

Section 1.

There is established, in the Office of the Secretary of Education, a Presidential advisory committee entitled the "President's Board of Advisors on Historically Black Colleges and Universities" (Board). The Board shall prepare and issue an annual report to the President on the results of the participation of historically black colleges and universities in Federal programs. The Board also shall provide advice to the President and to the Secretary of Education (Secretary) regarding the needs of historically black colleges and universities in the areas of infrastructure, academic programs, and faculty and institutional development. In the annual report to the President, the Board shall make recommendations on how to increase the private sector role, including the role of private foundations, in strengthening historically black colleges and universities. Particular emphasis should also be given in the report to enhancing institutional planning and development, strengthening fiscal stability and financial management, and improving institutional infrastructure, including the use of technology, to ensure the long-term viability and enhancement of these institutions.

Section 2.

The Board shall be appointed by the President. The Board membership shall include sitting presidents of historically black colleges and universities, representatives of other higher education institutions, business and financial leaders, representatives of private foundations, and secondary school administrators. The President shall designate a Chair or Co-Chairs from among the members.

Section 3.

The White House Initiative on Historically Black Colleges and Universities (Initiative), located in the Office of the Secretary of Education, shall: (1) provide staff, resources, and assistance to the Board; (2) assist the Secretary in performing the liaison function between the executive branch and historically black colleges and universities; and (3) serve the Secretary in carrying out the responsibilities described in section 6 of this order.

Section 4.

To carry out this order, each executive department and agency identified by the Secretary may, consistent with applicable law and regulations, enter into appropriate grants, contracts, or cooperative agreements with historically black colleges and universities. The head of each department or agency so identified shall establish an annual plan that will establish clear goals for how the department or agency intends to increase the capacity of historically black colleges and universities to compete effectively for grants, contracts, or cooperative agreements and to encourage historically black colleges and universities to participate in Federal programs. The department's or agency's annual goal should be clearly reflected in the department's or agency's annual budget sub- mission to the Office of Management and Budget. To facilitate the attainment of these goals, the head of each department or agency identified by the Secretary shall provide, as appropriate, technical assistance and information to HBCUs regarding the program activities of the department or agency and the preparation of applications or proposals for grants, contracts, or cooperative agreements.

Section 5.

Each executive department and agency identified by the Secretary shall appoint a senior official, who is a full-time officer of the Federal Government, to report directly to the department or agency head with respect to department or agency activity under this order, and to serve as liaison to the Board and to the Initiative. To the extent permitted by law and regulations, each executive department and agency identified by the Secretary shall provide appropriate information requested by the Board and staff pursuant to the order.

Section 6.

Each executive department and agency identified by the Secretary shall develop an annual plan for, and shall document the agency's effort in, increasing the capacity of historically black colleges and universities to participate in Federal programs. Each department's and agency's plan shall describe new or existing department and agency programs and measurable objectives for proposed department and agency actions, in connection with those programs, to achieve the purposes of this order. These plans shall be submitted at such time and in such form as the Secretary shall require. In consultation with the participating departments and agencies, the Secretary shall review the plans and develop, with the advice of the Board, an integrated Annual Federal Plan for Assistance to Historically Black Colleges and Universities for submission to the President. The Secretary shall provide the president of each historically black college and university with a copy of, and an opportunity to comment on, the proposed Annual Federal Plan prior to its submission to the President. Each participating department and agency shall submit to the Secretary an Annual Performance Report that shall measure each department's and agency's performance against the objectives set forth in the department's or agency's annual plan. The Secretary shall be responsible for monitoring compliance with the Annual Federal Plan after it is approved by the President.

Section 7.

In developing its annual plan, each executive department and agency identified by the Secretary shall emphasize programs and activities that develop the capacity of historically black colleges and universities to contribute to the development of human capital and to strengthen America's economic and technological base through: (1) infrastructure development and acquisitions for instruction and research; (2) student and faculty doctoral fellowships and faculty development; (3) domestic and international faculty and student exchanges and study-abroad opportunities; (4) undergraduate and graduate student internships; and (5) summer, part-time, and permanent employment opportunities.

Section 8.

Each year, the Board shall report to the President on the progress achieved in enhancing the capacity of historically black colleges and universities to serve their students, including findings and recommendations for individual departments and agencies in connection with their Annual Performance Reports, as described in section 6 of this order.

Section 9.

The Board, in consultation with the Department of Education and other executive departments and agencies, shall develop a Private Sector Strategy to assist historically black colleges and universities in: (1) increasing voluntary private-sector contributions to support the enhancement of endowments and the overall financial stability of such institutions; (2) improving and enhancing the quality and number of private-sector partnerships focused on academic program development, student achievement and faculty development, cooperative research and development projects, and faculty exchanges; and (3) improving information management, and facilities, and strengthening academic course offerings.

Section 10.

- 1. The provisions in this Executive Order shall be implemented to the fullest extent permitted by law.
- 2. The Department of Education shall provide funding and administrative support for the Board and the Initiative.
- 3. Members of the Board shall serve without compensation, but shall be reimbursed for all travel expenses, including per diem in lieu of subsistence, as authorized by law.
- 4. Insofar as the Federal Advisory Committee Act, as amended, may apply to the Board, any functions of the President under that Act, except for those in section 6 of that Act, shall be performed by the Department of Education, in accordance with the guidelines that have been issued by the Administrator of General Services.

Section 11.

Executive Order 12876 of November 1, 1993, as amended, is hereby revoked.
