HHS provides more financial support to HBCUs than any federal agency aside from the Department of Education

 - Garret Lee-Smith Campus Suicide Prevention Program
 - Minority Serving Institutions (MSI) partnerships with Community-Based Organizations (MSI-CBO)



HBCU Programs/Opportunities within HHS (Continued)

- NIH Research Centers in Minority Institutions Program
 - Develops and strengthens the research infrastructure necessary to conduct biomedical research and foster the next generation of researchers from underrepresented populations
- HRSA Bureau of Health Workforce
 - Supports funding for HBCUs supporting research development, training, program evaluation and other activities
- CDC Undergraduate Public Health Scholars (CUPS) Program
 - Internship opportunities creating a public health workplace experience to increase student interest in minority health
