National Threat Evaluation and Reporting Program



Every day, homeland security partners at all levels of government—federal, state, local, tribal, territorial (F/SLTT)—are working to keep Americans safe. Working together, we can enhance our ability to identify and prevent incidents of terrorism and targeted violence across the United States.

Many of our partners observe and/or receive reports of suspicious or threatening activity, either from concerned citizens or through the course of their official duties. Although an action or an activity reported may not seem significant, when reviewed in context with other similar actions, activities, or reports, it could become an essential element in preventing terrorist activity or other threats to homeland security.

NTER is a joint collaborative effort by the US Department of Homeland Security and federal, state, local, tribal, and territorial partners (SLTT).

WHAT WE DO...

As the threat landscape continues to evolve, the NTER Program empowers our homeland security partners to adapt to new threats and prevent terrorism and targeted violence. The NTER Program advances our partner's ability to identify, investigate, assess, report and share tips and leads linked to emerging homeland security threats, while providing program support, resources, and training.

BUILDING ON THE SUCCESSES OF THE NSI

The NTER Program builds on the success of the Nationwide Suspicious Activity Reporting (SAR) Initiative (NSI). The NSI, a joint collaborative effort by the U.S. Department of Homeland Security, the Federal Bureau of Investigation (FBI), and federal, state, local, tribal, and territorial law enforcement partners, is a standardized process for identifying and reporting suspicious activity in jurisdictions across the US and additionally serves as the unified focal point for sharing SAR information. The NSI provides standards, policies, processes, and trainings that allow fusion centers and law enforcement agencies to easily share information to help identify and prevent terrorist threats.

INTEGRATING BEHAVIORAL THREAT ASSESSMENT

As the threat environment continues to change, NTER is integrating behavioral threat assessment processes into its program to assist F/SLTT partners in adapting to prevent homeland security threats of targeted violence. NTER's Master Trainer Program (MTP) opens the aperture for threat reporting using a behavioral threat assessment approach. The MTP is a train-the-trainer initiative that certifies F/SLTT homeland security partners in behavioral threat assessment techniques and best practices. The MTP is building a national network of Master Trainers to teach partners in their communities to identify and assess risk and warning signs and assist in managing potential homeland security threats of targeted violence.

- It empowers local partners by providing them with resources, program support, and materials to educate partners in their areas of responsibility.
- Course materials were developed from the evidence-based behavioral threat assessment frameworks of the Federal Bureau of Investigation (FBI) and the United States Secret Service (USSS) and refined through engagement with the USSS's National Threat Assessment Center (NTAC) and a broad network of experts in behavioral threat assessment from all levels of government.
